ATTENTION ALL CDL HOLDERS

If you have a DOT physical or a CDL coming due, you must renew 30 days or more in advance and ensure that we have received a copy. Louisville based drivers, you may renew your physical at Baptistworx with the authorization slip found on the Safety bulletin board in Dispatch or given to you by your supervisor. If you are unable to get to Baptistworx during their normal business hours you may renew at Concentra on Fern Valley Road which is open 24 hours, but you will need to contact Paula at ext. 2760 to get an online authorization entered before you go. Sharonville, OH and Newport, MI drivers you need to renew at Concentra in your area. Please reach out to Paula at ext. 2760 to get an online authorization entered. UNIDENTIFIED DRIVE TIME

Unassigned drive time happens when you move a tractor without logging into the Isaac tablet. It is your responsibility to login every time you move a tractor. It is a carrier's responsibility to account for all unassigned drive time by assigning it to the driver that moved the tractor. If the ELD is malfunctioning, please contact someone in Safety or the Shop. If you login and you get a message to review unassigned drive time, make sure you review it to determine if the drive time belongs to you or not. If it does, accept it and sign your logs. If the time does not belong to you then reject it. Call a member of Safety with any questions about unassigned drive time.

Example: If you move a truck to access another and do not login, this will create unidentified drive time. We will research to find out who moved the truck and assign it to the person who moved the truck. If we have to spend unnecessary time researching, then we will assign remedial training to the driver who created the issue.

DRIVER REFERRAL PROGRAM

We are hiring and need your help finding good, quality Driver candidates that meet the following qualifications:

NEW KY SCHOOL BUS LAW
